#### Addendum A

The land in said Sturbridge, with the buildings thereon, opening on the southeasterly side of Westwood Drive, and also situated on the westerly shore of Cedar Pond, bounded and described as follows:

Beginning at the northwesterly corner thereof, at an iron pipe on the southeasterly side of Westwood Drive, at land of Bruce C. Curtis et ux., formerly of Richard D. May, being Lot 20 on a plan of land of said May section 2 by W. Morse, D. Murray and R. DeFalco, dated May 22, 1973, and filed with the Worcester District Deeds, Plan Book 383, Plan 103;

Thence by the southeasterly side of Westwood Drive: N. 68 degrees 50' E. 37.97 feet, more or less, and northeasterly along a curve to the left with a radius of 295.03 feet a distance of 119.28 feet to an iron pipe at land now or formerly of John C. Palmer, Jr. et ux.;

Thence by land now or formerly of said John C. Palmer, Jr., et ux.: southerly along a curve to the left with a radius of thirty (30) feet a distance of 43.60 feet to and iron pipe; and S. 67 degrees 30' 33" E. about 347.46 feet to an iron pipe at the westerly shore of Cedar Pond;

Thence southerly by the westerly shore of Cedar Pond to land now or formerly of Tetreault;

Thence N. 73 degrees 32' 14" W. by said Tetreault land and land now or formerly of one Caron about 382.2 feet to an iron pipe in stone wall at said May land;

Thence N. 23 degrees 57' 10" E. by said May land 1298.42 feet to an iron pipe at said Curtis land;

Thence by said Curtis land, being by Lot 20 on said plan: N. 23 degrees 57' 10" E. 70 feet to an iron pipe; N. 1 degree 19' W. 78.31 feet to an iron pipe; and northwesterly along a curve to the left with a radius of thirty (30) feet a distance of 57.52 feet to the point of beginning.

Subject to a right of way to said John C. Palmer, Jr. et ux. over a portion of the premises northerly of said course of S. 67 degrees 30' 33" E. extended westerly to Westwood Drive across the opening into the premises, and subject to right of said May to maintain drains for the development f his land generally along two natural streams easterly across the premises into Cedar Pond.

Together with all rights of way appurtenant to the same, including one heretofore used through the Edgerton and Hayward lots.
